Motions on Notice

601/41 Defining the management of Archery Victoria

There were 2 amended versions of this motion presented. After discussion the author withdrew the first and second versions and presented version 3 to the council. Discussion took place on the benefits for the Board in able to present and disseminate information with outside bodies such as SRV and AA.

Whilst the author recognised and accepted the doubts of the Council to remove its voting powers it was noted that for such an important decision that only 13 of the 26 clubs were in attendance, either in person or by proxy, and that 13 clubs had not responded to the motion in any fashion.
