Brendan Jones proposed an amendment to the motion as below.

From 1/1/2016, for AV Calendared Field Archery tournaments the following guidelines are set in addition to AA and WA field archery rules:

- 1. The course where practical may be set with substantial adjustment to peg distances and faces for each day of the tournament when compared to the host clubs regular course
- 2. Only essential field crew and judges will have access to the course after it is set and prior to the tournament.
- 3. The details of the course measurements shall remain confidential to the field crew and will not be shared with any entrants

#### 11. **General Business**

Leanne Strahan spoke on behalf of a group of Archers who believe that Irene Norman as MPO and the AV Board as a whole have acted in such a way as to cause a situation that has brought unwanted stress to them. This issue had been referred to the AA MPO, John Hans who has put it back into the hands of Irene Norman as MPO. This is an unsatisfactory result and as such, Leanne and the group will now liaise with Peter Bennett and Tania Sacco to try and resolve the issues.

A question was raised as to why Aim are still able to take new memberships while the prior club has been de-registered and the new club application has not yet been approved.

It was further discussed that AV have to date been unable to get in writing clarification as to whether the members of AIM are currently covered under the AA insurance policy

Until such time as proof is supplied that members of Aim as still covered a letter is to be sent out with an option that members can transfer to a new club for a period of 2 months while the new AIM application is accessed.

**Motion** that Waverley WAC and Sherbrooke SA will, pending approval of its committee, accept the people from the ex-Aim Archery Club, at no additional cost, that require insurance to shoot outside of the AIM business, for a period of not more than 2 months, while the new application is assessed. After that time, they can either join the new club and pay the associated fees for that club, or if the new incorporated club has been accepted, they can transfer back to the new AIM club.

Presidents to be notified that members from AIM will not be accepted to shoot at other venues until they have transferred their main membership to an incorporated club.

The letter which had previously been prepared by the AV board, will be sent to AIM members who are registered with AA, to outline the situation as it currently exists and actions which are required to be undertaken by them.

## **Indoor Nationals competitor applications**

It was suggested that initially only one entry/flight be allowed per archer with the exception those who require a second division for event selection when registering for the Indoor Nationals. This would allow for places for additional archers to compete at the events.

A suggestion was also made that an option for a separate State event prior to the National event could be arranged.

### **Club coaches Courses**

At present, there is no certified Club Coaching course available only coaching documentation.

As such, until a certified course is available, no Club coaching courses will be conducted.

Expressions of interest were shown from several attendees to participate in a registered coaching course and Irene Norman will investigate options.

## AV Calendar issues -

It was suggested that the current format of the existing AV calendar is desperately in need of rework. This will be addressed and rectified by the board.

State events should be fixed to a particular weekend for each year. This will allow for some consistency both when setting the new calendar and so that archers know when events are to be held and cut offs for team's selections are also know.

With events held over split dates, archers should be only able to enter one event or the other, similar to the indoor Nationals.

The board will take these suggestions on board for future events
