Archery Victoria Board Meeting Held via ZOOM Wednesday 20 Aug 2014 at 1930 hours

984.1. **Meeting Opens**

The President declared the meeting open at 1934h.

984.6. **Minutes from Previous Meeting**

The minutes of the Archery Victoria Board Meeting held via Zoom on 16 Jul 14 were distributed prior to the meeting, however Board Members had not had the opportunity to read them. Acceptance of these minutes will be held over to the next meeting.

984.10. **Reports**

- 984.10.1 **Presidents Report.** Nothing significant to report
- 984.10.2 **Administrator's Report.** The administrator's reports were submitted by Catalyst Consulting prior to the end of their contract on 21 August 2014. The Board noted that all information for the auditors for the 2014 Financial Statements had been submitted.
- 982.10.3 **Financial Reports.** The financial report (up to 16 August 2014) is attached at Annex C to these minutes. The Board noted that the financial statements presented for Board consideration included the period up to 16 August 2014 rather than the monthly statement for July 2014.
- 984.10.4 Officials Reports

Coaching Coordinator. IN advised that the three courses scheduled for 29 Jul 14, 2 Aug 14 and 9 Aug 14 had run successfully. The first 2 were held at BHCA whilst the 9 Aug 14 course was held at Wangaratta. If all coach candidates complete their requirements successfully we will have in excess of 40 new coaches in Victoria in 2014. It is expected that 2 more courses (1 metro, 1 rural) will need to be conducted before the end of the year. This will mean additional expenditure for the 2015 budget as the grant funding from SRV will not be sufficient to cover the costs. Unless additional funding is available, the cost to each participant for coaching courses in 2015 will increase.

- 982.10.4 **Grant Funding Updates.** No results have yet been received in relation to the SRV VMA audit. The revised budget for the Significant Event Funding grant has been submitted and accepted. Funding agreements for this grant are expected shortly.
- 982.10.6 **Board Mentor Reports.** Nothing significant to report.
- 984.10.7 **2014 Senior Nationals Update.** The minutes of the 2014 Senior Nationals Committee meetings are attached as Annex D to these Minutes.
- 984.10.8 **Policy Reviews.** No further work on policies this month.

984.11. Notices of Motion/Discussion Papers

No notices of motion were received.

984.12. General Business

984.12.1 New Club Application – HMAS Cerberus. GL advised that AA had requested consideration of a new club application for a club to be established at HMAS Cerberus. AA see this as an opportunity to break into a new segment of the market. Paperwork was submitted by the interested parties. Given that HMAS Cerberus is a military establishment GL had asked IN to review the documentation to ensure that all Department of Defence (DoD) requirements had been met. IN advised that she had completed that review and all seemed to be in order from the point of view of DoD. IN also advised that AA did not have concerns with a club on a DoD establishment not being incorporated. Considerable discussion ensued. The major issues discussed were the proximity of this club to an already established club in the area (Angel Archers at Balnarring) payment of all association fees, safety and conduct by some members of this proposed club. The Board noted that the club at HMAS Cerberus had been running as a trial – under DoD guidance – for several months. The Board noted that Angel Archers had considerable concerns about the proposal from a safety perspective as well as the proximity to their club. There was also some concern about how the club would be set up and membership requirements around joining AV and AA. PNF and DNF undertook to discuss the issues with the XO at HMAS Cerberus. GL undertook to clarify safety issues with the applicants. IN undertook to review all the paperwork submitted and determine what changes may need to be made to meet the requirements of AV and AA. Further discussion at the next meeting.

Sports Administrator Handover. The Board noted the formal advice from Catalyst Consulting terminating their contract with AV wef 21 Aug 14. IN advised that the handover of documentation and equipment had occurred am hours 20 Aug 14. All appeared to be in order with a comprehensive handover document provided. The Board expressed its disappointment that neither Bonnie nor Kate had been present for the handover. PNF provided (via email prior to the meeting) an analysis of the requirements in relation to administrative support. All Board Members were requested to consider this information and provide feedback to IN by 1 Sep 14. This information will then be used to advertise for a replacement administrator. The issue of how to advertise was discussed. It was agreed that we may need to go wider than archery circles to get the person we are seeking.

Judges – Progress of Candidate Judges. IN expressed concern about the progress of National Judge Candidates (NJCs) and the lack of information being provided by the Judge Co-ordinator on who will be judging which tournaments. After some discussion it was agreed that judges for tournaments would be placed on the AV website prior to the tournament – IN to request information for upcoming tournaments from the Judge Co-ordinator. IN is also to request a progress report on NJCs to ensure that they are on track to being qualified as full judges. The Board expressed concern that AV's investment in judge training would be wasted funds if candidates did not have the opportunity to complete their requirements and become part of the official roster. A further judges course will be needed in 2015, however, a method of ensuring that the NJCs were provided with adequate opportunities to complete their requirements was needed.

982.12.4 **2015 National/State Indoor Championships.** GL distributed an email prior to the meeting from Marcus Anear from Diamond Valley Archers. Marcus advised that

DVA would be hosting portion of the Indoor National Championships next year and expressed some opinions about the arrangements which have been in place up until now. The Board expressed concern that the issues raised by Mr Anear were largely unfounded and unsubstantiated. The Board further noted that no complaints had been received by AV in relation to the 2014 National and State Indoor Championships. The Board further noted that in 2013 AV had undertaken to examine the format of the National/State Indoor Championship to determine if multiple venues or other arrangements would be more suitable to the current needs of AV and our archers. The issue was considered for the 2014 event but the lack of available judges and suitable venues were issues and the current format (single venue) remained for the 2014 championships. The issue of the 2015 championships was discussed and the Board agreed to a review of the format of these championships as at least one of the issues – judges – had been addressed. GL was asked to consider this issue in light of the development of the 2015 calendar and come back to the Board with options for this review - this may include the formation of a working party or sub-committee to provide options to the AV Board. GL to respond to Mr Anear.
